## Admissions Policy for Academic Year 2023/2024

Highfields Academy is part of Star Academy Trust and the school's Local Advisory Board is the admissions authority. The admissions policy has been designed to comply with the Schools Admissions Code 2014 and all relevant legislation, including that on infant class sizes and equal opportunities.

# 1) Admissions to the Reception Year

Subject to the criteria set out below, children will be admitted in the September following their fourth birthday. The academy has an agreed admission number (the published admission number or PAN) of 30 pupils for entry in reception. The academy will accordingly admit up to 30 pupils.

Places will be allocated by the Local Advisory Board on the basis of applications received through the Cheshire East admissions system. This allows parents/guardians to apply for entry to any Cheshire East primary school by means of the Cheshire East Primary School Common Application Form (CAF) available in the 'Applying for school Places' document published by Cheshire East Council (CEC) and on-line via the CEC website. The school will offer places on a full time basis from the start of the Autumn Term.

## 2. "In-Year" Admissions

## Oversubscription Criteria for all types of admissions:

Once children with EHC plans, naming Highfields Academy have been admitted, then places are allocated in accordance with the order of the following oversubscription rules:

- 1. 'Looked after children' and children who were previously 'looked after'. A 'looked after child' is a child who is in the care of a local authority or being provided with accommodation by a local authority (as defined in section 22 of the Children Act 1989) at the time of making the application to school. Children previously 'looked after' are children who were looked after as defined above, but immediately after being 'looked after' became subject to an adoption, child arrangement, or special guardianship order. An adoption order is an order under section 46 of the Adoption and Children act 2002. A 'child arrangement order' is an order settling the arrangements to be made as to the person with whom the child is to live under section 8 of the Children Act 1989. Section 14A of the Children Act 1989 defines a 'special guardianship order' as an order appointing one or more individuals to be a child's special guardian (or special guardians).
- 2. Siblings pupils with brothers or sisters step-brothers or step-sisters, foster brother or sisters, half-brother or half-sisters, adopted brothers or adopted sisters living together as part of one household, already attending the preferred school (in years reception through to year 6) and expected to continue at the school in the following school year (i.e. at the time of admission).
- 3. Children resident within the designated catchment area of the school children will be classed within this criterion if they and their parents/carers are resident within the area served by the school.

- 4. Children who currently attend Little Crickets Preschool at Highfields Academy.
- 5. Pupils living nearest to the school measured using the National Land and Property Gazetteer (NLPG) which measures straight line distances in miles from the school's coordinate point to the point of residence's coordinate point.

#### Tie-Breaker:

If there are more applicants than there are places remaining within a particular category, and where there are siblings or there is no difference in distance from home to the Academy for two or more children, random allocation will be used to allocate the final available place(s).

An admissions panel, including the principal and two members of the Local Advisory Board who are not employed by the academy, will apply the oversubscription criteria.

# **Exceeding the school's PAN – sibling applications.**

We believe that families should be able to attend the same school. The school <u>may</u> decide to exceed the PAN in Key Stage 2 if we receive multiple applications for siblings. However, this will be dependent on the current class sizes and whether admitting extra pupils would be detrimental to those already on roll. We will not exceed our PAN for Foundation and KS1 applications unless there are exceptional and permitted reasons.

# Examples:

- We receive an application for places in Year 1, 4 and 5. We currently have space in Year 1 and Year 4 but there are already 30 children in Year 5. The admissions panel may decide to exceed the PAN in Year 5 so that all children can be accommodated.
- We receive an application for places in Year 1, 4 and 5. We currently have space in Year 4 and Year 5 but there are already 30 children in Year 1. The admissions panel will not offer places as this would exceed the statutory limit of 30 places in a Key Stage 1 class.

### **Fair Access Protocol:**

The academy participates in Cheshire East Local Authority Fair Access protocol.

# Right of Appeal:

In the event of an unsuccessful application, parents have the right to appeal to an independent appeals panel against non-admission. Appeal forms can be requested from the academy and appeals can be lodge up to 20 school days from the date of the offer letter. Where an in year application and subsequent appeal are unsuccessful the Admissions Authority will not consider a repeat application within the same academic year unless there has been a relevant and significant change of circumstances relating to the application, or a place has become available in school.

The academy will hold a waiting list until the end of the Autumn term for the Reception intake and parents are asked to keep in touch to find out if a place has become available.
